EFFECTS OF OVEREXPOSURE

Primary Route of Entry:

Skin:
Defatting to skin on repeated contact.

Ingestion:
May be irritating to the gastrointestinal system. Large doses can cause vomiting and diarrhea.

Inhalation:
Get to fresh air, if breathing is difficult. Seek medical attention if symptoms persist.

Ingestion:
Do not induce vomiting. Rinse mouth with water and drink one glass of water. Seek medical attention immediately.
